If I am the successful bidder of a lot, I shall sign an award report for each lot awarded, and I shall undertake to collect the lots within 15 (fifteen) days from awarding, prior to payment of the full amount of the hammer price, in addition to auction fees. I acknowledge that Faraone, at its own discretion, may request the buyer to pay a deposit to finalize the knock down, on the same day of the auction.
